☐ Tax return 2025 and envelope

Income (in Switzerland as well as abroad)

- ☐ Yearly salary statement(s) main and extra income / unemployment benefit(s) / daily allowance 2025
- ☐ Balance and income statement (incl. details) of self-employed activity from 1.1.25 – 31.12.25
- ☐ Social security and pension statement(s) 2025: AHV, IV, pension fund, SUVA, foreign pension, etc. (if additional payments incl. disposal)
- ☐ Alimony: received alimony in 2025; child alimony have to be declared separately (copy of separation/divorce convention please enclose)

Property owners (in Switzerland as well as abroad)

- ☐ Information about properties (imputed rental value, tax value and construction year); foreign properties purchase contract(s); german properties the german unit value "deutscher Einheitswert"
- ☐ Net rental income (without additional charges) 2025. Apartment building: rent schedule and maybe rental contracts
- ☐ Copy of paid invoices of maintenance 2025 (e.g. building insurance, chimney sweeper, boiler service etc.). The invoice date is relevant.
- ☐ Statement from the condominium association (balance sheet, income statement and costs allocation), incl. renewal fund 2025
- ☐ Paid building lease charges (Baurechtszinsen) 2025
- ☐ Copie(s) of received financial contribution for the efforts concerning energy and ecology activities / proof of payments of the buyback price of the photovoltaic construction in 2025

Fortune/wealth (in Switzerland as well as abroad)

- ☐ Balance statement(s) as of December 31 and interest statement 2025 of all your bank and postale accounts, original document from your lottery win (domestic lottery and domestic sports betting a. o. are tax free up to CHF 1 Mio.)
- ☐ Wealth tax statement 2025 (includes balances, income, purchases and sales) or custody statements 2025 (includes only the balances at the end of the year, that's why we need also all dividend statements and all documents about purchases and sales)
- ☐ Inheritance: copy of the inventory (date of death, your part of the inheritance, property holdings). Inheritances have to be declared in the year the testator died. The income and wealth are taxable from the heirs (from the date of death until the end of the year)
- ☐ Details about received or given gift(s) in 2025
- ☐ Documents of the surrender value of life insurances as of 31.12.2025
- ☐ Motor vehicle (car/motorbike): details about brand, purchase price and production year / when leased: information about an existing leasing contract
- ☐ Other assets (money in cash, precious metal, gems, collections, crypto currency etc.)
- ☐ Loans or current accounts in legal entities

Professional expenses/further education

- ☐ All expenses have to be proved e.g. computer purchase except the costs for public transportation (TNW area).
- ☐ Car kilometers from your home adress to your office in 2025 and a confirmation from your employer that you need the car for your work. If you have a company car: information about the km to/from the workplace (free of charge transport)
- ☐ Part-time employment: number of work days / working time and employment factor in %
- ☐ Extra costs for weekly commuters (copy of rental contract and costs for the weekly homecoming with the public transportation)
- ☐ Further education and retraining costs: copies from the bills e.g. language course, coaching etc.

Debts/interest on debt

- ☐ Balance as of December 31, 2025 as well as the paid interests in the year 2025 (mortgage, loan, credit, credit cards, current account liabilities, the owed taxes)

Further deductions/indications

- ☐ Confirmation of the payments into the 2nd and 3rd pillar pension in 2025
- ☐ Receipts/documents of the charitable donations and also member ships of political parties in 2025
- ☐ Payment receipts for support contributions in 2025 incl. information about the supported person. For foreign payments: proof that the supported person is needy is mostly necessary
- ☐ Yearly statement of your health insurance 2025 (excluding premiums)
- ☐ Self paid doctor bills or dentist bills. Nursing home costs (yearly statement) and other health costs which are invoiced in 2025. If you didn't reach the franchise you have to proof it
- ☐ Children: name, date of birth, kind and duration of education/school/studies; official residence
- ☐ Payment receipts of your child care costs in 2025 (only until the age of 14)
- ☐ Alimony: paid alimony in 2025; child alimony have to be declared separately (copy of separation/divorce convention please enclose)
- ☐ Paid AHV contribution 2025 for unemployed persons
- ☐ Documents about received lump sum payment(s) in 2025
- ☐ Information about your marital status and confession
